PRÉSENTATION

But

Le présent rapport rend compte des activités d'approvisionnement et de passation des marchés du gouvernement du Nunavut dans l'optique d'accroître l'intégrité et la transparence des pratiques en la matière, par la présentation de renseignements significatifs et utiles en temps opportun.

Introduction

La structure du présent rapport s'inspire des procédures de passation des marchés du gouvernement du Nunavut et des renseignements accessibles dans les bases de données de la Société d'habitation du Nunavut (SHN). Le rapport comprend des renseignements statistiques ainsi que des détails relatifs aux contrats de la SHN et aux contrats d'exploitation et d'entretien pour l'exercice 2018-2019.

Vue d'ensemble du rapport

Le rapport porte sur la répartition des marchés attribués aux entreprises selon la désignation qui leur est accordée en vertu de la politique Nunavummi Nangminiqatunik Ikajuuti (désignation de la NNI). Les désignations sont définies ci-dessous.

INUIT :	Entreprises appartenant à des Inuits et inscrites au registre de la Nunavut Tunngavik Incorporated (NTI).
NUNAVUT :	Entreprises inscrites au registre du gouvernement du Nunavut.
AUTRE :	Aucune des trois désignations ci-dessus.

Dans les fiches de données à l'appui, une entreprise qui est inscrite à la fois au registre de la NTI et à celui de NNI (NTI/NNI) est classée dans le résumé sous « Inuit ». Une entreprise inscrite seulement au registre de NNI est classée sous « Nunavut ». Finalement, une entreprise qui n'est inscrite ni au registre de la NTI ni à celui de NNI est classée sous « autre ».

Les renseignements détaillés sur les contrats attribués sont répartis en deux sections, soit la **section A** et la **section B**.

La section A porte sur les grands travaux de construction. Conformément au manuel des procédures contractuelles du gouvernement (*Government of Nunavut Contracting Procedures Manual*), cette section comprend aussi les contrats d'une valeur de 25 000 \$ ou plus.

La section B traite des contrats d'exploitation et d'entretien (biens, services, entretien, locations) et de tous les autres contrats de plus de 5 000 \$.

Cette section porte sur les baux des logements du personnel et logements sociaux qui appartiennent à la SHN.

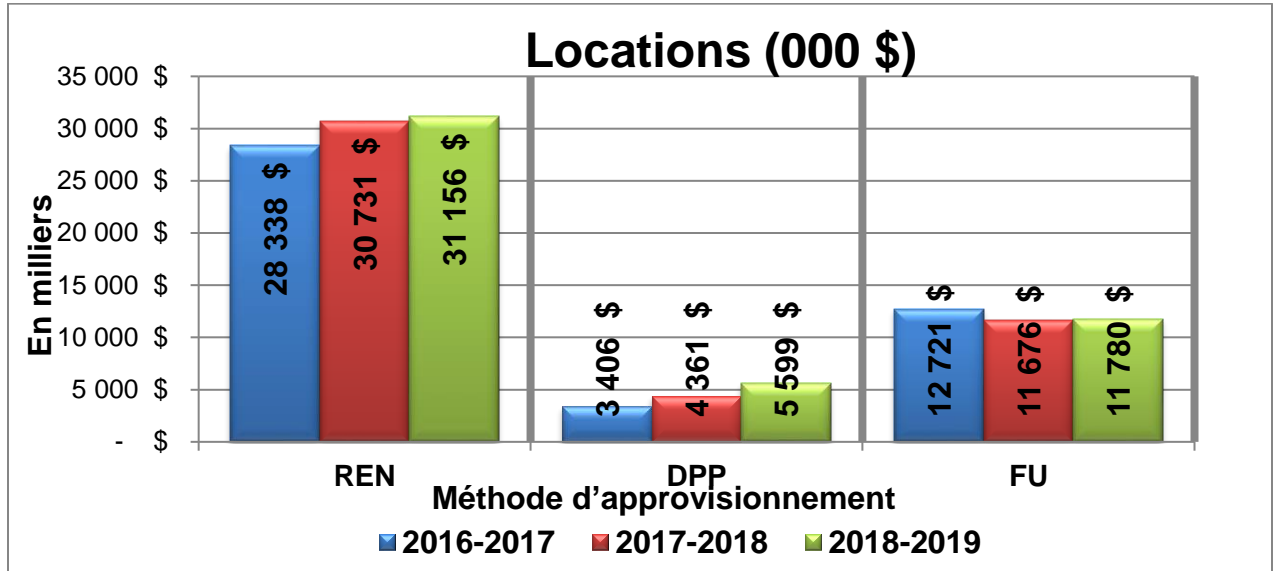
En 2018-2019, les nouveaux baux ont principalement été conclus à la suite de demandes de propositions publique. La SHN a opté, là où c'était possible, pour le renouvellement de la majorité de ses baux, puisque les unités étaient déjà occupées par des locataires de logements du personnel ou sociaux, et que le non-renouvellement aurait grandement perturbé les opérations.

Les baux signés selon les protocoles d'entente (PE) concernent des logements acquis au nom des ministères du Nunavut. La durée des baux (nouveaux ou renouvelés) est d'un à cinq ans.

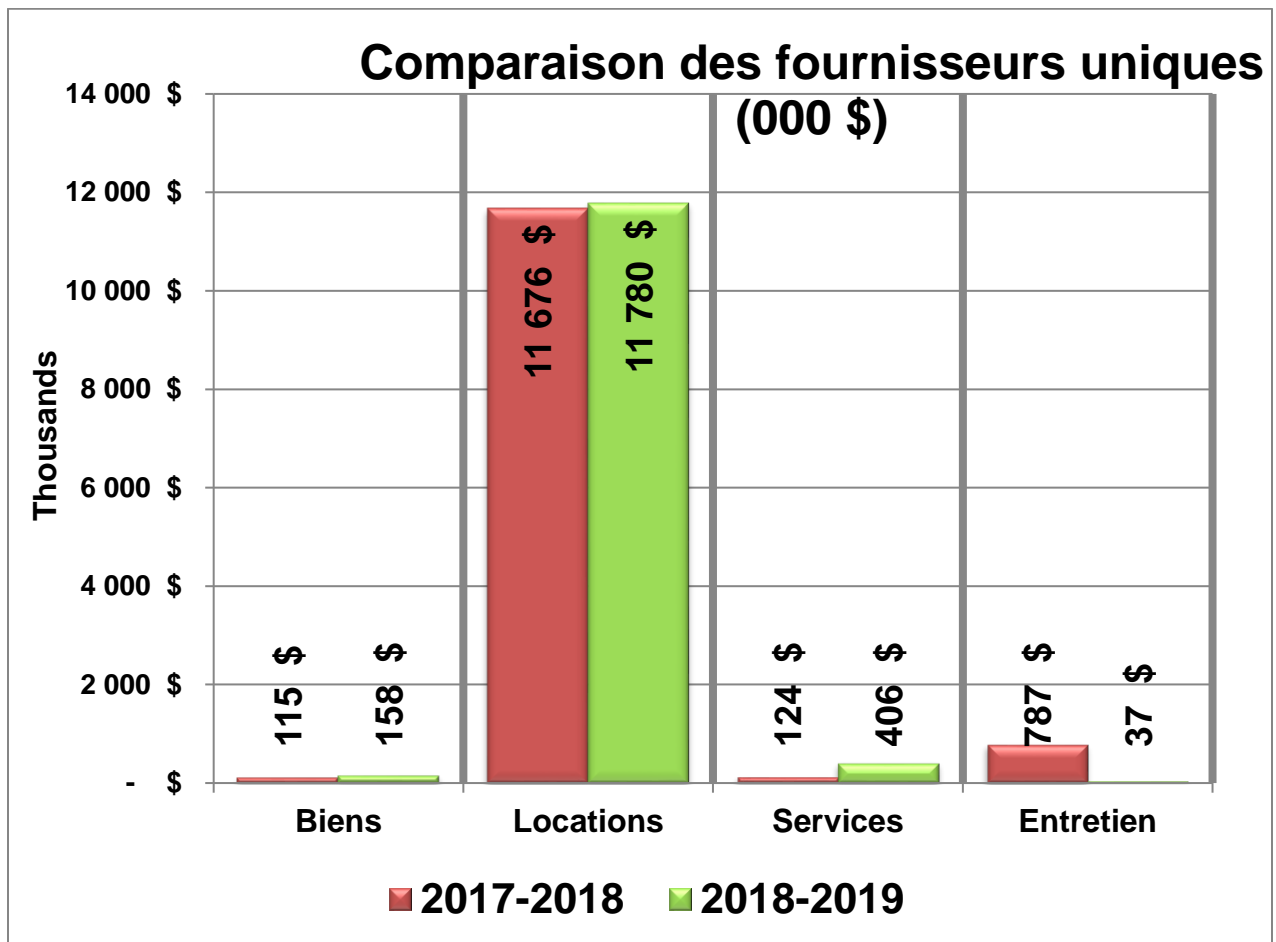
Comparaison des fournisseurs uniques

Les pratiques d'attribution de contrats à des fournisseurs uniques sont surveillées étroitement. La SHN croit qu'il est possible d'obtenir le meilleur rapport qualité-prix dans le cadre d'appels d'offres concurrentiels. Il existe cependant quelques circonstances acceptables où le gouvernement peut attribuer un contrat sans lancer d'appel d'offres :

1. Si les biens, les services ou la construction visés par le contrat sont requis d'urgence, et que tout retard était préjudiciable à l'intérêt public.
2. Si une seule partie est disponible et en mesure de réaliser le contrat.
3. S'il s'agit d'un contrat d'architecture ou d'ingénierie dont la valeur ne dépassera pas 25 000 \$, ou d'un contrat d'une autre nature dont la valeur ne dépassera pas 5 000 \$.

Biens : La plupart des contrats avec des fournisseurs uniques concernent des logiciels spécialisés et des services informatiques.

Locations : Dans certains cas, la SHN doit conclure des ententes de location avec des fournisseurs uniques en raison de la rareté des logements locatifs disponibles.

Services : L'augmentation est attribuable à l'embauche d'un cabinet inuit pour fournir à la SHN des services de consultation lors des projets de construction.

Entretien : La réduction est attribuable à l'expiration d'un contrat à long terme pour la gestion des logements du personnel situés à Rankin Inlet. La direction a été en mesure de lancer un appel d'offres public pour ce contrat en 2018-2019.

Définitions

Approvisionnement en biens : Dans le présent rapport, contrat pour l'achat de biens conclu surtout par la Société d'habitation du Nunavut au moyen d'un bon de commande.

Appel d'offres sur invitation : Appel d'offres pour lequel les documents ne sont envoyés qu'à des entrepreneurs ou fournisseurs choisis.

Appel d'offres public : Appels d'offres annoncés publiquement.

Fournisseur unique : La meilleure façon de définir ce type de contrat consiste à en énumérer les critères. Le Règlement sur les contrats du gouvernement, pris en application de la Loi sur la gestion des finances publiques, permet la sélection d'un fournisseur unique lorsqu'une autorité contractante a des motifs raisonnables de croire :

- a) que les biens, les services ou la construction visés par le contrat sont requis d'urgence et que tout retard serait préjudiciable à l'intérêt public;
- b) qu'une seule partie est disponible et en mesure d'exécuter le contrat;
- c) qu'il s'agit d'un contrat pour des services d'architecture ou d'ingénierie dont la valeur ne dépassera pas 25 000 \$;
- d) qu'il s'agit d'un contrat d'une autre nature dont la valeur ne dépassera pas 5 000 \$.

Demande de soumissions : Elles s'appliquent « lorsque le gouvernement sait quel résultat il veut obtenir, mais pas nécessairement comment l'obtenir. Par conséquent, il demande des propositions relatives aux méthodes, aux compétences et au prix. Le gouvernement peut donc négocier la meilleure méthode en vue d'obtenir la meilleure valeur ».

Appel d'offres : L'appel d'offres peut faire l'objet d'annonces publiques ou d'invitations privées. Ce sont généralement la valeur et la nature du contrat qui détermineront le type d'appel d'offres utilisé.
